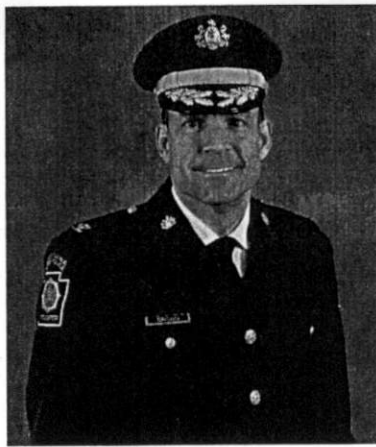

Biographical Information – Colonel Marcus L. Brown

Colonel Marcus L. Brown was nominated by Governor Tom Wolf to serve as the 22nd Commissioner of the Pennsylvania State Police on January 20, 2015. As Commissioner, he exercises administrative, command, and fiscal authority for the Department. He oversees a budget of over 876 million dollars and commands a statewide complement of over 6,000 enlisted and civilian employees, which includes over 4,700 State Police Troopers.

As the Commissioner of the State Police, he is empowered by statute to assist the Governor by enforcing the law and preserving peace through the detection of crime, apprehension of criminals, and patrol of the highways. He serves as Chairman of the Municipal Police Officers' Education and Training Commission.

A native of Cumberland County, Colonel Brown holds a Bachelor of Science in Business/Marketing from the Pennsylvania State University, as well as a Juris Doctor from the University of the Baltimore School of Law.

Colonel Brown has a 25 year career in law enforcement, the majority of which was with the Baltimore City Police Department. While there, he served as the Commander of Special Operations, Internal Affairs, Northwest Patrol District and Legal Affairs. He finished his career in Baltimore as the Deputy Commissioner of Operations which is the second highest ranking position in the Department. In 2007, he was appointed Chief of the Maryland Transportation Authority Police where he remained until he was appointed Superintendent of the Maryland State Police in August 2011, serving until January 2015.

Colonel Brown has held many leadership positions on the state and national level and is active in many organizations. He was named President of the Maryland Chiefs of Police in 2013, and previously served as the Vice President in 2011. He was the Chair of the Statewide (Communications) Interoperability Committee, the Maryland Police & Correctional Training Commissions, and the Superintendent's Council of Advisors on Diversity and Inclusion. He was a member of the Governor's Family Violence Council and the Maryland Center for School Safety. He was an active member of the Police Executive Research Forum and the International Association of Chiefs of Police. He also oversaw the Office of the State Fire Marshal and the Maryland Fusion Center which fall within the organizational structure of the Maryland State Police.

As Superintendent of the Maryland State Police, Colonel Brown organized the creation of the Special Operations Bureau and the reorganization of the Criminal Investigation Bureau. These changes allowed the Maryland State Police to focus on inter-jurisdictional statewide crime and improved the ability to effect local crime trends and, along with Maryland State Police's strong relationship with local law enforcement, resulted in historic reductions in statewide crime and traffic fatalities.

Under Colonel Brown's leadership, the Maryland State Police became nationally accredited for the first time in 2014. The Department is the first State Police agency in the country to receive the CALEA Tri-Arc Award for accreditation in law enforcement, communications, and training.

Secretary of cabinet-level Department of State Government empowered by statute to assist the Governor by enforcing the law and preserving peace through the detection of crime, apprehension of criminals, and patrol of the highways. Serves as Chairman of the Municipal Police Officers' Education and Training Commission and as a Board Member on various commissions and councils.

Superintendent, Maryland Department of State Police (2011 – 2015)

Secretary of cabinet-level Department of State Government that included the Maryland State Police, Office of the State Fire Marshal, and the Maryland Fusion Center. Commanded 2,400 sworn and civilian employees. Successfully implemented statewide crime-fighting strategies focused on strong community relations and targeted enforcement, which resulted in 30-year lows in violent and property crime. Created a Strategic Plan and built consensus for a major organizational change, to include the creation of the Special Operations Bureau and the consolidation of investigators into the Criminal Investigation Bureau. Oversaw major improvements, including a new \$30 million Computer Aided Dispatch/Records Management System, 10 new medevac helicopters, a \$1 billion 700 MHz Radio System, and a budget of \$350 million. In 2014, the Maryland State Police became the first State Police agency in the country to be CALEA accredited in the Law Enforcement, Communications, and Training Academy programs. *Holds Top Secret Clearance with the Department of Homeland Security.*

Chief, Maryland Transportation Authority Police (2007 – 2011)

Responsible for the overall management and operation of Maryland's seventh largest police department comprised of over 600 police officers and civilians. The force actively patrols major highways and provides law enforcement services to much of the state's critical infrastructures, such as major bridges and tunnels, the Port of Baltimore, and the BWI Thurgood Marshall Airport. Revised and implemented Continuity of Operation Plans and security plans at all facilities. Successfully implemented operational programs that improved the Department's crime-fighting capabilities. Enhanced the Department's internal administrative function with significant improvements in the area of unbiased policing. Initiated the accreditation process for Communications and Training Academy programs resulting in the Department receiving the CALEA Tri-Arc Award in 2011.

Deputy Commissioner, Operations, Baltimore Police Department (2005 – 2007)

Second highest command rank within the Baltimore Police Department, which is the ninth largest police department in the nation. Responsible for a \$226 million budget and over 3,000 officers in the Patrol Division, Detective Division, Homeland Security Division, and Organized Crime Division. Created and implemented a crime reduction strategy that resulted in Baltimore's lowest crime rates in over 30 years.

Chief, Internal Affairs Division, Baltimore Police Department (2004 – 2005)

Command responsibility for the operation of the Internal Affairs Division, including all internal investigations, complaints, and prosecutions. This included the management of 50 detectives and supervisors.

Major, Northwest District Commander, Baltimore Police Department (2003 – 2004)

Commander of the Northwest Patrol District which was comprised of over 150 officers and civilians. Responsible for the development of crime reduction plans and the strategic deployment of resources to implement those plans. Analyzed data and presented crime statistics and strategies within the COMSTAT framework. Developed and maintained a strong Community Relations Counsel and implemented several "Citizens on Patrol" neighborhood crime watch programs, which resulted in the lowest violent crime rate of any district at that time.

Major, Organized Crime Division Commander, Baltimore Police Department (2002 – 2003)

Created and implemented a unified crime fighting strategy encompassing Narcotics, Auto Theft, Federal Task Forces (HIDTA), Computer Crimes, and Asset Forfeiture.

ACCOMPLISHMENTS

Successful Implementation of Crime Reduction Strategies:

- Maryland recorded historic 40-year lows in homicides and both violent and property crime (2013).
- Maryland recorded historic 50-year lows in fatal and non-fatal traffic accidents (2013).
- Maryland violent crimes committed against women and children driven down by 25 percent (2007–2013).
- State Police Impaired Driving Effort (SPIDRE) – DUI Team lead effort that reduced DUI deaths by 15% (2013).
- Transformed the Maryland Fusion Center (MCAC) into a real-time crime center which analyzes and disseminates crime information throughout the state.
- Sanctuary Preservation – developed and implemented a program to stop illegal poaching within the oyster and clam sanctuaries in the Chesapeake Bay.
- Maryland Center for School Safety was created after the Sandy Hook school shooting, to ensure statewide coordination on school safety.
- Maryland Gun Center developed to ensure that all criminal gun cases receive targeted prosecution.
- Baltimore City experienced reductions in all major crime categories, including 30-year lows in violent crime.

Homeland Security:

- The Maryland Fusion Center (MCAC) became a national model and received a perfect rating from the Department of Homeland Security (2013).
- Maryland Emergency Management Agency (MEMA) – Maryland State Police Troopers assigned regionally across the state to ensure continuity of operations.
- The State Law Enforcement Coordinating Council was created to coordinate the emergency response efforts of all state law enforcement.
- Statewide 700 MHz Radio System rolled out across the state.
- BWI Thurgood Marshall Airport designated by TSA as security model for the nation.
- Port of Baltimore receives outstanding security rating from the Department of Homeland Security.

Creating a Diverse Workforce:

- Maryland ranks first in African-American representation among all State Police agencies in the mid-Atlantic.
- Since 2011, Maryland has more than doubled the representation of minorities in State Police senior staff.
- Since 2011, the Maryland State Police has increased the average academy minority rate to 32 percent.
- The retention rate for minority Academy candidates has improved to 76 percent in 2014 – up from 25 percent in 2008.
- The retention and graduation of female Trooper candidates has increased to 71 percent in 2011–2014 compared to 59 percent in 2008–2011. Three times as many women graduated from the Academy in 2011–2014 compared to 2008–2011.

Reducing Domestic Violence:

- Maryland had a statewide reduction of 25 percent in crime against women and children (2007–2012).
- In January 2013, the Maryland State Police designated Domestic Violence Coordinators (DVC) in each Barracks.
- The Maryland State Police Forensic Sciences Division completed the analysis of 60 sexual assault forensic evidence kits, a 50 percent increase over 2011.
- The Forensic Sciences Division analyzed 66 DNA samples related to sex crimes, a 29 percent increase over 2011.
- The Maryland State Police Computer Crimes Unit conducted 147 investigations of sexually exploited or abused children, a 568 percent increase over the 2011 total.
- The Maryland State Police Internet Crimes Against Children Task Force conducted 717 investigations of sexually exploited or abused children, a 1,228 percent increase over the 2011 total.
- The Maryland State Police completed 899 post-conviction sex offender polygraph examinations, a 243 percent increase over the 2011 total.

Supporting Military Veterans:

- Maryland State Police Military Support and Recruitment Liaison serves as a veteran recruiter and military liaison for current employees who serve in the military reserve.
